Meaning we must finalize Buchtel Trailhead location and provide ODNR agreements between Buchtel and Land Owner(s) for review.

- The big news is we received \$234,240 of Athens County ARPA investment for ORCA staff, which is 3.2% of the \$7.1 million of unique Athens County tourism infrastructure investments ORCA secured from September- December 2022.
- Our account balance as of today is \$324,298.82. It's going to diminish significantly when we pay our construction bills and reimburse our partners in the power grant.

In June ORCA was one of more than 500 organizations to submit an application to receive an Economic Recovery Corps fellow. Our application advanced to phase two which was an interview, Ohio University Economics Professor Dr. Julia Paxton-Pagon graciously joined the interview. There are two more phases of the application process, but if selected we will receive an IDEC paid Economic Recovery Corps Fellow for 2.5 years to advance economic planning for the region.

#### **Communications Report:**

### Delia Palmisano

- Social media continues to grow. Facebook is up 134 people from last month to 4,745 followers. The reach last month was over 37,000. Highest post for Facebook is new trails as well as the post about the Dirt Fondo and a meet the team post about Jessie reached 2,800 people. So it felt like it was important for people to know who's behind ORCA and the Baileys.
- Instagram is up as well, 33 people from last month to 2,451 followers.
- The ORCA website in the last 30 days reached 262 site visits to 191 unique visitors. Seems like when people are on there, they're spending a fair amount of time on there, so over five and a half minutes on the website.
- The Baileys in the last 30 days is obviously reaching much more. 3,207 site visits, 2,200 unique visitors and over 7,000 page views. Baileys website traffic comes from a lot of

Facebook referrals, and things like bike reg about the Dirt Fondo Ride. ORCA traffic seems to come from more organic searches and google searches.

- The ORCA expansion Press release went out to 20 or so media outlets in the 16 county area and it got picked up in Highland, Ross and Athens counties.
- The Dirt Fondo, which is October 14th, has 40 people registered. This time last month we had 18. I think that'll continue to grow as it gets closer. The TREK bike raffle generated around \$520 raised last month and currently we're at \$1,150. We have ads that'll be coming out soon on WOUB and then Facebook boosted posts as well. We have a list of sponsors that we're continuing to grow. Cash donations, tables, foods, raffle items, etc.
