## • Sunday Creek Horizons Contract

• Mayor Amy Renner—Motion on one-month Sunday Creek Horizon contract Jessie Powers, Executive Director

- Sunday Creek Horizon will help set up meetings with legislators and craft messaging to secure state support. This project's alignment with state priorities outlined in the 2019 Ohio Trails Vision and recreation's critical role during the current pandemic suggest a unique opportunity to secure state support for the Baileys Trail System. The proposal outlines \$7,000 a month for 4 months, and following month one SCH will provide a recommendation to continue services, if success seems likely. I recommend we enter into the contract for one month of service as proposed, which increases ORCA's capacity to pursue other support revenues from grants etc.

  - Patterson—engagement from Board members
    - Who should be the best person to accompany Jessie to meetings
    - Look ahead to fund future months if we decide to continue services
